Information for authors- full paper in proceedings

Language of presentation: Portuguese, English or Spanish

Each article should not exceed 15 pages (including list of references and appendix) and must proceed as follows:

- tables and figures referenced and presented throughout the text;
- references throughout the text according to the author/data system (surname, year: page – formal citation) – (surname, year – conceptual citation).
- list of references presented in alphabetical order of the 1st author surname.

Article Structure

Title:

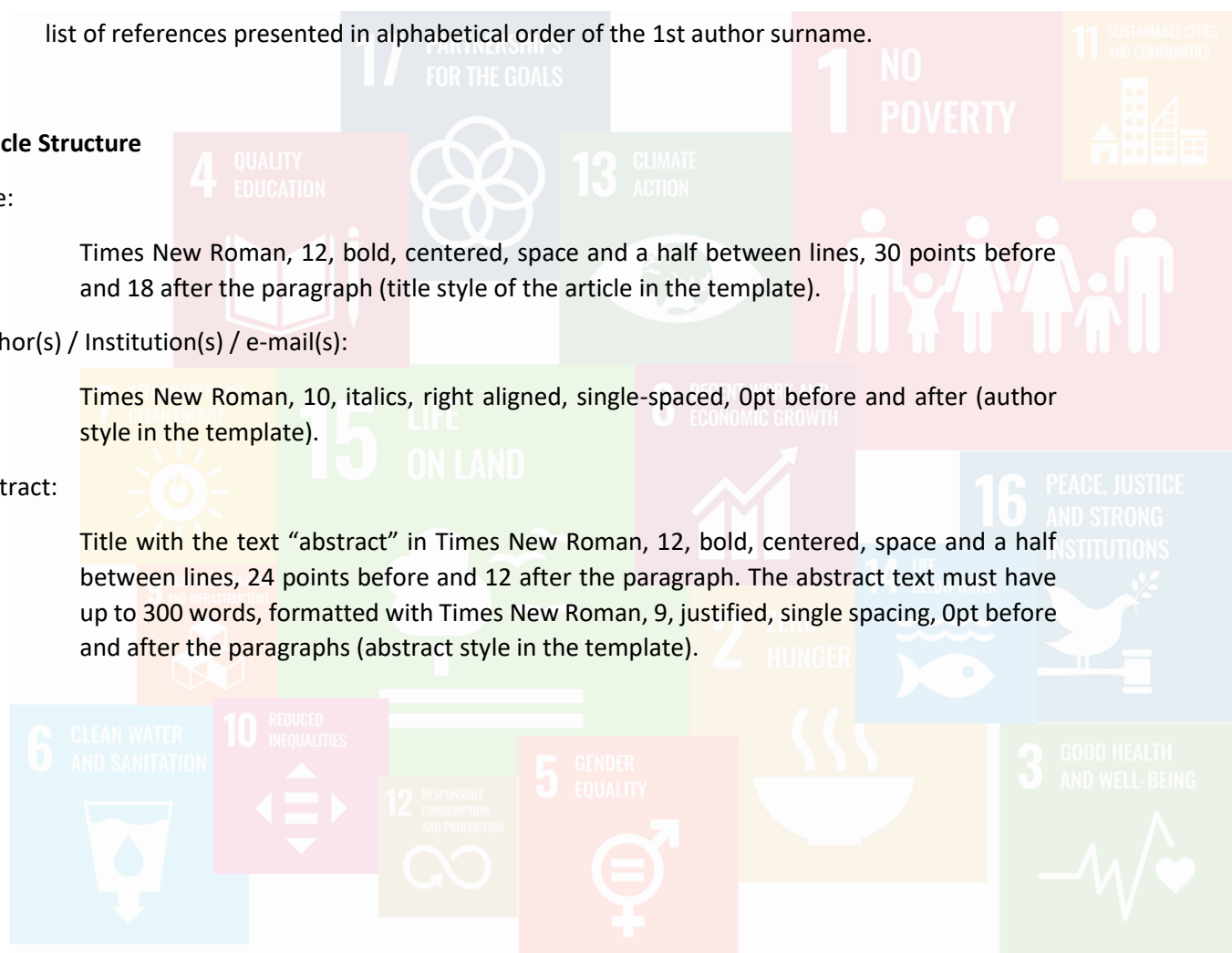
Times New Roman, 12, bold, centered, space and a half between lines, 30 points before and 18 after the paragraph (title style of the article in the template).

Author(s) / Institution(s) / e-mail(s):

Times New Roman, 10, italics, right aligned, single-spaced, Opt before and after (author style in the template).

Abstract:

Title with the text “abstract” in Times New Roman, 12, bold, centered, space and a half between lines, 24 points before and 12 after the paragraph. The abstract text must have up to 300 words, formatted with Times New Roman, 9, justified, single spacing, Opt before and after the paragraphs (abstract style in the template).



Keywords:

Keywords must be identified with “Keywords” in bold. The entire paragraph must be formatted with Times New Roman, 9, single-spaced, 18pt before and 12pt after the paragraph (keywords style in the template).

Article Sections:

In addition to the abstract, the article must contain introduction, development, conclusion and list of references; the development should consist of sections that the author considers relevant in which the titles, like the introduction and conclusion, are placed in an autonomous line, and will be formatted with Times New Roman, 12, bold, single line spacing, 6pt before and after the paragraph, not being numbered (section style in the template).

Section's text:

The text must be formatted with Times New Roman, 12, justified, 1.5 between lines and 6pt before the paragraphs (normal style in the template).

List of references:

The list of references must be formatted with Times New Roman, 10, justified, single spacing, 3pt before and after paragraphs, indentation pending lines after the first (hanging) of 1,25 cm. The name of the article/book/journal can be highlighted in italics (bibliography style in the template).
